TCDC's Strategic Plan State Provides \$12,500 LUPTAP Grant

The Pennsylvania Department of Community & Economic Development (DCED) awarded a \$12,500 Land Use Planning Assistance Grant (LUPTAP) to *TCDC* on January 9, 2001 for the development of an Updated Strategic Plan for Tioga County. The Corporation will match the State funds with a cash contribution from **GPU Energy**, funding from the **49 CORRIDOR Enterprise Zone** and local cash and In Kind from *TCDC*. The Corporation has retained the firm of **VanLandingham Consulting** to undertake the Update. **Wade VanLandingham** has provided consulting assistance to *TCDC* for several years.

OUTREACH to the Future, the original Strategic Plan for Tioga County was completed in 1992 as Tioga County's first Strategic Plan. Much has happened since then. The *Tioga County Development Corporation* was merely a concept; the economic climate was dismal; unemployment was high; and Tioga County still did not have a four lane limited access highway. It is amazing what can occur in less than a decade. Tioga County now has a lower unemployment rate than in the recent past; Ward Manufacturing, Inc.'s ACP and WARDFLEX have located in Lawrence Township; many of our industries have experienced growth and an increase in employment; the **49 CORRIDOR** exists; US Route 15's four lane highway system has entered eleven miles into our County; **Leadership Tioga County** now exists; several *School To Work* and *Work Force Development* Programs are assisting in providing a quality work force; and presently, Tioga County has a work force shortage.

Specific Problems to be addressed include: Workforce Issues: updating skills for new employment opportunities, commutation (especially into New York State), underemployment, labor force participation, etc.; Land Availability for industrial and business park development; Options for Funding and Operating the Enterprise Zone after the State closeout; Land Use concerns along the Major Highway Corridors in Tioga County; and meeting the needs of Existing Employers in the County. A Public Meeting is tentatively scheduled for September 6, 2001 to solicit input from the community for the *OUTREACH To The Future: Going Forward from 2000*.

The Planning process will involve a series of twenty seven meetings with the *TCDC* Board, local businesses & industries, local industrial development organizations, Tioga County Visitors Bureau, Tioga County Planning Commission, Northern Tier Regional Planning & Development Commission, Tioga County *School To Work* Partners and the Tioga County Farm Preservation Committee. A *TCDC* Board retreat will occur in September to develop our next three Year Work Program.

1st 49 CORRIDOR Revolving Loan Fund (RLF) Check Presented R & T Mechanical, Inc. under Construction in Lawrenceville Borough

The first Revolving Loan Fund (RLF) through the **49 CORRIDOR Enterprise Zone** was approved on August 30, 2000, closed on January 22, 2001 and a Check Presentation Ceremony was held on April 26, 2001. With construction going on in the background, Timothy J. Baughman received a "Ceremonial Check for \$30,000" from Scott Keck, Chair, RLF Committee; Donald Carman, *TCDC* Director and **49 CORRIDOR** Representative; Carol Kilko, State Director, *TEAM Pennsylvan!a*; Debra Mathers, *NTRPDC TEAM Pennsylvan!a* Program Manager; and Robert J. Blair and Lillian Smith, *TCDC*.

R & T Mechanical, Inc., located along US Route 15, **Lawrence Township**, Tioga County, Pennsylvania with Corporate offices in Bainbridge, Pennsylvania, received the very first RLF in the EZP. **Timothy J. Baughman**, President & CEO and **Ronald E. Hunt**, Vice President & Acting Secretary are the owners. **R & T Mechanical, Inc.** is an industrial mechanical contractor providing services for manufacturing, in areas of new process installation and maintenance of existing processes. R & T was established and incorporated on February 12, 1987 in Lancaster County. Development of a branch operation in Tioga County is being planned to increase sales and better serve customers in the Tioga County Area. A 7,500 square feet manufacturing facility is being constructed in the Lawrenceville Borough. This will be Lawrenceville's first industrial manufacturing operation. Employment will go from thirteen (13) employees in Tioga County to twenty five (25) within three (3) years.

TEAM Pennsylvan!a Business Calling Program 2000 - 2001

TEAM Pennsylvan!a is a dynamic public-private partnership formed to bring business, government, and community and economic development together, making the Commonwealth's businesses and communities stronger in the 21st Century. As the *TEAM Pennsylvan!a* Agent for Tioga County, designated by the Tioga County Board of Commissioners, the *Tioga County Development Corporation* operates this Business Retention Program.

TEAM Pennsylvan!a's Business Calling Program (BCP) is designed to obtain information from businesses to assist the Commonwealth in establishing business policy for the future. Through the Interview Process, specific needs of a company are identified based on the needs and contact is made by *NTRPDC*, *TCDC* and other service providers to provide public assistance to the business. For the Program Year July 1, 2000 through June 30, 2001, 40 interviews were completed. We exceeded *NTRPDC*'s goal of 25 and completed an additional 15 bonus interviews.

During a recent visit to the Northern Tier Region by Carol Kilko, *TEAM Pennsylvan!a* State Director, an on-site Interview was conducted by Debra Mathers, *NTRPDC TEAM Pennsylvan!a* Program Manager, Robert J. Blair and Lillian Smith, *TCDC* with Timothy J. Baughman, President & CEO of R & T Mechanical, Inc. The interview was held immediately following the **49CORRIDOR** Check Presentation (see **49CORRIDOR** article above).

Madigan (R, 23rd Senatorial District) and State Representative Matthew E. Baker (R, 68th Legislative District) provided comments from the State perspective affecting economic development and other related issues impacting Tioga County.

49 CORRIDOR Update Basic Planning Grant Year 6 Received

The **Pennsylvania Department of Community & Economic Development (DCED)** awarded the **Tioga County Redevelopment Authority** with a \$50,000 Basic Planning Assistance Grant for the Program Year 6 (July 1, 2000 through June 30, 2001) in May 2001. The funds are used to support the **49 CORRIDOR Enterprise Zone** through the *Tioga County Development Corporation*, the Administrative Entity for the Enterprise Zone Program (EZP). Funds are used; 1) to improve the economic climate in the nine (9) municipalities (**Deerfield Township, Nelson Township, Elkland Borough, Knoxville Borough, Osceola Township, Lawrenceville Borough, Lawrence Township, Westfield Borough and Westfield Township**) Enterprise Zone in the Northern portion of Tioga County; 2) for the development and implementation of the Business Development Strategies (based in a structured survey of local businesses and reflecting the needs of the local private sector); 3) to actively foster and promote the economy of "The Cowanesque Valley"; and 4) for the Administration of the Enterprise Zone. Eleven (11) industries in the EZP account for one third (1/3) of the manufacturing base of Tioga County with 1,368 Jobs and an Annual Payroll of over \$24 Million. These industries are located on 290 acres of land and have over 887,371 total square feet of building area comprised of 18 parcels of land.

Since the **49 CORRIDOR Enterprise Zone** was designated in 1985, three (3) Competitive Grants of \$250,000 each have been awarded to the EZP and loans have been made to **ElectriCord Manufacturing, Inc.** and **Ward Manufacturing, Inc.** Phase I and Phase II of the **WARDFLEX®** Project. Proceeds from the loans are administered by **Citizens & Northern Bank** and are available to be loaned to industries and manufacturers in the Enterprise Zone. The first RLF Loan was approved in August 2000 to **R & T Mechanical, Inc.** (See related story on Page 3)

“Town Meeting”

Career & Technology Education (CTE) and Work Force Development

On May 4, 2001, a **“Town Meeting”** was held at the **Pennsylvania College of Technology/ North Campus** from 1:30 PM to 3:30 PM. The concept for the **“Town Meeting”** resulted from a meeting with **Congressman John Peterson**, **TCDC** President Cummings, Immediate Past President C. Frederick LaVancher, and Executive Director Robert J. Blair during a recent tour to Tioga County by the Congressman.

The intention was to have an Open Dialogue and involve the audience as much as possible. There was an extensive list of presenters who were each allotted 3-4 minutes to speak on the planned topics and then the audience was allowed to ask questions during the **“Town Meeting”** portion of the presentation. The layout for the Meeting was set up in a “Talk Show” Format and the Event was taped by **Blue Ridge Communications, Inc. TV Channel 13**.

The Program was comprised of three (3) sections: the **LEGISLATIVE PERSPECTIVE: Work Force Development: Jobs! Jobs! Jobs!**; the **BUSINESS PERSPECTIVE: What We Need in a Work Force**; and the **EDUCATIONAL PERSPECTIVE: Where We are & Where We are Going**. The Legislative portion of the meeting involved **Pennsylvania Senator Roger A. Madigan**, **Pennsylvania Representative Matthew E. Baker**, and **Michael Glazer**, aide to United States Congressman Peterson. They provided comments relative to overall Work Force Development showing the connection between Business & Industry, the Educational Sector and the Public Sector. During the Business portion of the meeting, **Thomas Rice** of **Dominion Transmission**, **Ferlin Patrick** of **Eagle Family Foods, Inc.**, and **Bill Williams** of **Ward Manufacturing, Inc.** addressed the Work Force needs their companies are facing and how we can work together to assure they will have a qualified Work Force for the present and the future. **Debbie Mathers**, Program Manager for **TEAM Pennsylvan!a (NTRPDC)**, gave a brief report on the Business Calling Program and the priority employers place on Work Force Development Issues. The Educational portion of the meeting consisted of **Jacqueline Bellamy**, Superintendent of **Northern Tioga School District**, **Ronald Boyanowski**, Superintendent of **Southern Tioga School District**, **Donna Mettler**, Superintendent of **Wellsboro Area School District**, **Michael Lane**, Provost of **Mansfield University**, and **Larry Michael**, Associate Dean of **Pennsylvania College of Technology**. Each educator provided a brief summary of their Organization’s Career Development Policy, their goals and objectives, and how they are addressing them.

To close the meeting, **OUR NEXT STEP: Working Together to Assure a Quality Work Force in Tioga County** was discussed to tie in all three perspectives. **Kim Coon**, President of the Educational Resources Group for the State System of Higher Education, was on hand and related his experience in Bedford County as a County Commissioner and offered his assistance in his new position to assist Tioga County to take the next step. The **“Town Meeting”** was a forum for the consideration of what future steps we can take to make sure we can provide our students with a valuable quality education regardless of what profession or vocation they pursue and to meet the needs of our business & industry, providing them with a quality Work Force.

LEDA Grant Received from DCED

State Economic Development Assistance Funds Increase

Showing its commitment to local grassroots economic development, the **Pennsylvania Department of Community & Economic Development (DCED)** doubled the **Local Economic Development Assistance (LEDA)** Grant Program Funds to economic development organizations throughout the Commonwealth. The **Tioga County Development Corporation** is designated by **Tioga County Commissioners Erick J. Coolidge, Walther G. Barnes and Charles James** as the lead economic development organization in Tioga County. For the year July 1, 2000 through June 30, 2001, **TCDC** received \$17,814 in May 2001. **TCDC** works closely with the other two (2) state designated IDC’s in our County, the **Betterment Organization of Mansfield (BOOM)** and **Growth Resources of Wellsboro Foundation (GROW)**. The LEDA Funds support the county economic development efforts of **TCDC** to foster and promote the economic development of Tioga County.

The increase in the LEDA funds is the direct result of the involvement of the **Pennsylvania Economic Development Association (PEDA)**. The 2001-2002 DCED Budget includes another increase of the LEDA Program by fifty percent. LEDA Funds are the only direct State funding provided to Industrial Development Corporations at the local grassroots level in the Commonwealth.

TCDC commends the **Pennsylvania Department of Community & Economic Development** for providing this critical funding; the **Pennsylvania Economic Development Association** for leading the charge on behalf of local economic development for LEDA funding; and to the **Tioga County Commissioners** for designating **TCDC** as the lead economic development for Tioga County.

Tioga County Career Days

The *Tioga County Career Day Steering Committee* met on November 9, 2000 and established the dates for the three (3) Career Days in Tioga County for the 2000-2001 School Year. 14th Annual Tioga County High School Career Day
