New Business Receives \$150,000 **TCEZ** RLF Loan

On Wednesday, May 7, 2008 the *Tioga County Development Corporation* closed a **Tioga County Enterprise Zone (TCEZ)** Revolving Loan Fund loan to Gehman's Ornamental Iron - North Voice Communications located in Knoxville, Pennsylvania. The \$150,000 loan will be utilized to purchase machinery and equipment along with start up costs. Jason Gehman, Vice President/Chief Information Officer stated, "**Tioga County Enterprise Zone (TCEZ)** RLF is playing a major part in making North Voice Communications a world class Contact Center with highly competitive pricing. Due in part to low interest rates from the **TCEZ** RLF, North Voice can offer quality Order Entry, Customer Service, and complete Answering Service for both the telephone and the web, with quality local agents, for less than other national or outsourced contact centers."

North Voice Communications is a Call Center that houses 24 to 48 agents along with administrative and training staff to handle inbound calls for a wide array of clients. The call center is located in Knoxville, Pennsylvania in renovated space at 206 South First Street.

Bradford Forest Receives \$150,000 **TCEZ** RLF Loan

The *Tioga County Development Corporation (TCDC)* conducted a **Tioga County Enterprise Zone (TCEZ)** Revolving Loan Fund loan closing on May 6, 2008. Bradford Forest, Inc. received a \$150,000 loan from the **TCEZ** Revolving Loan Fund toward their total project costs of \$500,000. TCDC is assisting Bradford Forest, Inc. in purchasing a replacement for an old saw system. The company purchased an up-to-date USN trim saw and two hands free, semi-automatic board dealer type grading stations equipped with console activated Grading & Trimming decision inputs, PLC linked to the trimmer and optical measurement system.

“We have worked with Bradford Forest, Inc. in the past through the **49 CORRIDOR** Enterprise Zone Program and are extremely pleased to be able to continue to assist them through the **Tioga County Enterprise Zone**,” stated Robert J. Blair, TCDC President/Chief Executive Officer. Bradford Forest, Inc. has been in existence in Tioga County since 2001 and employs 65 people and also supports several other independent loggers and trucking contractors in the lumber industry.

The **Tioga County Enterprise Zone** is currently looking for industries and manufacturing firms in the Enterprise Zone to lend low interest Revolving Loan Funds for expansion projects. Any industry located in one of the twelve (12) Areas of the state designated enterprise zone may be eligible for low interest loans of 2.50%.

Special Olympics Bocce Court Dedication

On Wednesday, April 16, 2008 the Tioga County Special Olympics committee held a dedication ceremony for the two new bocce courts built behind Partners in Progress in Mansfield. These bocce courts were built with a \$10,000 grant from the Pennsylvania Department of Community and Economic Development (DCED).

David Cummings, *Tioga County Development Corporation* Chairman and Bob Blair, *Tioga County Development Corporation* President/CEO started the process for the grant and Senator Scarnati saw that the Special Olympics of Tioga County received the grant. The Special Olympics Committee of Tioga County also received a \$5,000 Reebok Lifetime Sports grant from Special Olympics, Pennsylvania to help pay for the new courts. This money is given to local Special Olympics committees who start a lifetime sport such as bocce.

After the cutting of the ribbon, Special Olympics athletes demonstrated how bocce is played and then

PEDA Releases Groundbreaking Report on State of Economic Development in Pennsylvania



Several Members of PEDA including Robert J. Blair, 1st Vice President of PEDA conducted a Media Event on the steps of the Rotunda to reveal the results of the study. Patrick Killian, PEDA President presented the finding.

The Pennsylvania Economic Development Association (PEDA) on February 22, 2008, unveiled a groundbreaking new report that reveals its members have partnered with local, state and federal governments, as well as the private sector, to leverage \$4.8 billion in investments in Pennsylvania that have helped to create 186,000 jobs.

The report, "2007 Economic Development Corporation Impact and Client Satisfactory Study," covers work done by PEDA Members during the first four years of the Rendell Administration, from 2003-2006. To determine impact, surveys were completed of PEDA members and their customers.

"The results are clear. PEDA, through our member economic and industrial development corporations are making a dramatic difference in communities all across the state," said Robert J. Blair, President/CEO of the *Tioga County Development Corporation*. "We are getting results. The local industrial groups throughout Pennsylvania are at the very core, working with our industries and businesses."

Among the other findings were:

- Industrial Development Corporations (IDC) worked with funding sources to help provide more than \$1.45 billion from grants, loans, tax credits and other sources to clients;
- Through IDC assistance, respondents also leveraged more than \$3.35 billion in private equity, bank participation and bond sales;
- IDCs account for more than \$1 billion in activity every year;
- The top method of job creation reported in the survey is expanding local businesses
- As experienced community leaders that understand their communities, IDC officials target specific industries for promotion and recruitment

- Target industries include cutting edge fields in biomedical, health care and information technology; and
- The most commonly used funding sources are the Pennsylvania Industrial Development Authority (PIDA) and the federal Economic Development Administration (EDA) and Governor Edward G. Rendell's Economic Stimulus Package.

During the time of the study, a wide array of development projects were initiated statewide, including several from Tioga County:

- A \$3,500,000 PEDFA Loan for Tyoga Container impacting 44 manufacturing jobs
- Dr. Robert Strohecker's historic renovation of the TW Judge Company in Mansfield through a PEDFA loan of \$400,000
- A 49 CORRIDOR Loan of \$75,000 to Gehman LLP in Knoxville for anew pallet operation
- Enterprise Loans to Bradford Forest; R & T Mechanical and Tyoga Container totaling \$450,000 distribution center, Bedford County; and
- USDA RLF loans to Rakoski NAPA of Lawrenceville and Freeman Muffler Shop Plus, Inc. in Deerfield Township totaling \$50,000
- A \$400,000 PEDFA loan to The Murus Company for expansion of their facility in Rutland Township

"The study clearly identified economic development in Pennsylvania as a partnership of the private sector, state, federal and local government and talented economic development professionals at the regional and local levels throughout Pennsylvania," said PEDA President J. Patrick Killian, who is a volunteer with PEDA and professional economic developer who is the Director of the Delaware County Commerce Center. "We especially want to note and thank Secretary Dennis Yablonsky and the Pennsylvania Department of Community and Economic Development and members of the General Assembly for providing both leadership and partnership."

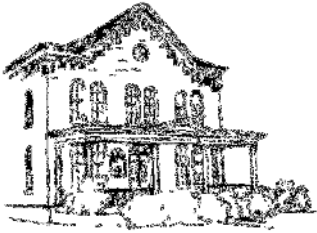
